Dear Mr. Alyakritakiy.---

I hereby refer to your letter of 5 June 2015 in connection with your request to: (i) provisionally increase the number of air carriers to operate charter flights from Moscow to points in Spain; and (II) approve the program of Nordstar.

First of all, the Spanish Directorate General of Civil Aviation takes advantage of this opportunity to congratulate the airline on its determination to commence such services between our countries.

As regards your proposal to increase the number of carriers to operate charter (nonscheduled) flights from Moscow to points in Spain, I inform you that it is acceptable to the Spanish side. Therefore, from 8 June 2015 to the end of the Summer 2015 season, we will consider 16 air carriers to operate these flights. This acceptance is made on a provisional and extra-bilateral basis, on the understanding that a reciprocal treatment will be given to Spanish airlines.

Furthermore, we take note that the 16th Russian air carrier designated to operate on this route is Nordstar and convey this information to the Spanish Aviation Safety State Agency (AESA). Please advise contact **AESA** the airline (permises_comerciales@seguridadaerea.es) to complete the necessary procedures to obtain the appropriate permit.

I avail myself of this opportunity to express to you the assurances of my highest

consideration and to send you my best regards.
